

### **Healthcare Powers of Attorney & Living Wills**

Healthcare **Powers** Attorney and Living Wills are two very important legal documents that tend to cause confusion. Often. people think if they already have a Property Power of Attorney and a Last Will and Testament, they do not need these additional documents. However, Healthcare Powers of Attorney and Living Wills are completely different documents and address completely different issues.

While a Property Power of Attorney dictates who can make legal and financial decisions on your behalf, a Healthcare Power of Attorney allows you to name the people that you would want to make healthcare

decisions on your behalf if you were unable to do so yourself. This document tells your family what you would want to happen in several different situations so there is no confusion or fighting amongst family members if any of those scenarios happen to arise.

A Last Will and Testament explains how you would like your assets to be distributed upon your death whereas, a Living Will communicates your medical wishes if you were in a terminal condition or a permanently unconscious state. The Living Will gives you the ability to explain to your family what you would want to happen in an end of life situation and

thus removes the burden and stress of decision making from their shoulders if such circumstances should apply.

At first glance Living Wills and Healthcare Power Attorneys may seem very similar, but they are very different. For instance, the contacts named in your Livina Will cannot make healthcare decisions for you if you are unable to do so, only the agents in your Health Care Power of Attorney could. Because each document has its own intricacies and covers different situations, it is very important to have both documents in order to make sure your wishes are known when such an event occurs.
