

# **Paying for Long-Term Care**

Many elderly people assume that if they need long-term care, either at home or in a facility, that Medicare is going to pay for that care. The reality is that Medicare might pay for the care for a very limited amount of time. After that time, usually no 100 more than days maximum, Medicare will stop paying and the person needing care is going to have to find another way to that care. pav for

There are generally three ways to pay for long-term

• Private Pay: Simply means

that the person receiving care pays for his or her care "out of pocket."

- Long-Term Care Insurance: Usually a great option, but many people fail to consider long-term care insurance until it's too late. Either they wait until obtaining long-term care is too cost prohibitive or they wait until they are no longer medically qualified. It is always advisable to at least look at long-term care insurance as an option to see if you qualify.
- Medicaid: If a person has limited resources and does not have long-term care insurance then that individual may qualify for public

assistance. Medicaid is a federally funded, state administered program that is designed to help offset costs for people with limited income and resources. However, limited may not mean what you think it means.

Each situation is specific to that individual or couple and is why it is always advisable to seek the advice of an elder law attorney before applying for Medicaid benefits. Working with the right elder law firm could literally result in savings of hundreds of thousands of dollars.
