

Wills & Trusts: What You Think You Know

As a family estate planning attorney, clients often come to me with ideas about wills & trust that they learned from friends, neighbors, and the internet. I've come to realize that a lot of people think they know about wills & trusts – but they don't.

Unfortunately, most people don't ever find out they don't know, because by the time it comes to light, it's simply too late.

A will is, essentially, your ticket into probate court.

Many people think that if they have a will, they will avoid probate. Probate is the court process of validating the contents of a deceased individual's will.

All property that passes through a will, and therefore through probate court, is subject to any and all debt that you have during your life. I tell my clients, "Probate is a lawsuit you file against yourself, with your own money, on behalf of your creditors." What this means is your creditors, not your family, often get first dibs on your property.

Everything that your will says is completely public. Even worse, any property that passes through a will is public record. This can be bad for those left behind, because even the most sensible people, when in the grieving process, may be vulnerable to predators.
