

Prince's Legacy Shows Us the Importance of Estate Planning

As many of you may have heard on the news, Prince, the pop legend with chart-topping hits such as "Purple Rain" and "Little Red Corvette," died without any sort of estate plan in place. What this means, is that all of the assets and property that Prince saved during his lifetime, which is currently estimated at over 300 million dollars, will be distributed according to the laws of Minnesota, rather than going out according to Prince's wishes. In addition, it subjects the estate to expensive attorney fees, as well as both state and federal estate taxes.

This high profile case helps to serve as a reminder of why it is so important to have an estate plan in place. Although we may not be lucky enough to have 300 million dollars of assets upon our deaths, it is still important for us to have a plan in place, dictating how we would like our assets to be distributed when we pass. In Ohio, if someone passes away intestate (without a will), the Ohio Revised Code, Section 2105.06 instructs the court as to who will inherit your estate. For example, if you pass away and there is no surviving spouse, no children, and no parents, then the estate would be distributed to your brothers and sisters.

In Prince's case, Minnesota law is quite similar. With no surviving spouse, no known children, and no surviving parents, Prince's siblings would be the ones to inherit his estate. However, a claim was recently made against Prince's estate by a

person alleging to be Prince's biological son. If a blood test reveals that this man is indeed Prince's son, he would step up in the order of inheritance. Not only does this add time and stress to the already long and expensive probate process, but it also involves subjecting the decedent to blood testing in order to establish whether or not the claimant is indeed Prince's son.

Whether through trust planning or a simple will, it is so important to memorialize your wishes in regards to how you would like your assets to be distributed upon your death. We will never know who Prince would have liked to receive his estate, but I do know it will be a long and expensive road ahead for his family.

Matt's Message
