

### "What Happens to My Cars When I Pass Away?"

This is a common question with many misconceptions.

If you own your vehicle jointly with rights of survivorship, the other person named on the title would become the sole owner when you pass away. If you don't own your car jointly and you are the only one listed on the title, what happens then? Does your spouse automatically get the car? Well, it depends...

Under the current Ohio law, a surviving spouse may take up to two automobiles outside of the probate process, as long as the total value of the vehicles is under \$40,000. This means that the combined value of the vehicles that were transferred outside of

probate is not included in the total value of the estate (and not included in probate attorney fees!). In addition to the two automobiles, the surviving spouse can also take one boat, one boat trailer, and one outboard motor outside of probate as well.

If you are unmarried, then your vehicle would get a one-way ticket through probate unless you had a transfer on death beneficiary designation on your car title. Under the Ohio Revised Code, you can add a transfer on death beneficiary to your vehicle title, specifying who you would like to receive your motor

vehicle upon your death. This is done by visiting your local office (often times attached to an Ohio BMV) and telling the clerk that you would like to add a transfer on death (T.O.D.) beneficiary to your vehicle title. They will assist you with the form and print a new title with the designation clearly listed. Once you pass away, the beneficiary will be able to receive the vehicle, outside of probate, by returning to the title office with a few documents.
