

Basic Estate Planning Documents: The Foundation to Everyone's Estate Plan

Basic Estate Planning Documents include a will, power of attorney, healthcare power of attorney, and living will. Most of us know that in the will we list who gets our stuff and who is in charge of this. We know that both powers of attorney allow someone to speak on our behalf financially or medically. And we know that the living will allows us to decide what our end-of-life treatment would be like. Why is this so important?

Let's look at the story of Eric who was 18 years old. As the years went by, Eric made some wise decisions. He started a job, bought a house, got married, had children, started a retirement account, and bought some life insurance. By his mid-forties, Eric thought it was finally time to create that estate plan he had been thinking about for the past few years. But, Eric had yet to even lay his foundation. So, Eric met with the estate planning

attorneys and together they formulated a plan. But before Eric could sign his documents to put his plan into place, Eric was in a car accident. He didn't pass away but he did end up in a coma. Unfortunately because Eric never put a foundation in place, his wife was not authorized to speak on his behalf for non-life threatening medical decisions. And without a power of attorney document, Eric's wife was not authorized to sign his plan on his behalf. Because his plan could not be completed, all of Eric's accounts including his life insurance policy and IRA were left unchanged- the only beneficiary was his wife. Sadly, doctors determined Eric would not recover from the coma. Without a living will, his wife was forced to decide what she thought Eric would want. Unfortunately, Eric's parents disagreed. Eric's wife and parents ended up suing each other in court so they could fight

for what they believed Eric would have wanted. The trouble was that no one really knew exactly what Eric wanted- because he never made his intentions known. After years of court battles, the high court finally decided to remove Eric's life-sustaining treatments. And because Eric's estate plan was never put into place, there were no provisions for his children. The accounts that Eric had went to his wife as she was the only beneficiary listed. Shortly thereafter, Eric's wife remarried.

As you can see, no matter how young you are, it is always a good idea to lay your estate plan foundation. Had Eric laid his estate plan foundation, the circumstances after his car accident could have been handled smoothly, without use of the court system and his children would have been provided for by him. So, are you ready to lay out your estate plan foundation?

Matt's Message

As this newsletter "goes to press" so to speak, our attorneys are attending the Ohio Elder Law Institute's two-day block of instruction. The law is constantly in a state of change and keeping abreast of those changes is critical to developing a proper estate plan.

The beginning of this year found many law firms scrambling to adapt to the plethora of new rule changes that came out in January. At Donald Law Office we addressed these issues back in October of

2015 because we knew the changes were coming. How did we know before so many others? Because we make it our business to stay up-to-date of all the upcoming changes by attending continuing legal education (CLE) classes on a regular basis. We put a huge emphasis on anything that has to do with elder law.

The State of Ohio requires all attorneys to attend a minimum of 12 hours of CLE which can be on any topic. In our office, our attorneys focus our CLE classes on

elder law and estate planning. For example, last year Matt had more than five times the required amount (60.75 hours) in elder law estate planning alone.

So what does all this have to do with you? The point is simply this: who do you want creating your estate plan - a general practice attorney who completes just 12 hours of CLE in any field or a law office that is dedicated to being on the leading edge of elder law and estate planning?
