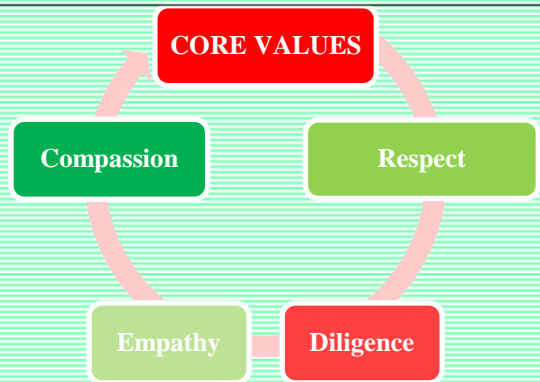

**The 7 Threats to Your Family Security**

**Threat 1: Losing Control and Access to Your Stuff.**
