Three Big Lies of Medicaid Qualification

Lie #1: If you need a nursing home, Medicaid will take your home.

They can't and they don't want to.

Lie #2: If you transfer assets, you have to wait 60 months to qualify.

There is no such rule.

Lie #3: You have to give your assets away to protect them.

You DO NOT have to give your stuff away to protect it.

Here are some clarifications about Medicaid:

Medicaid has a five-year LOOKBACK period. This means that if you gave away monetary gifts or made some other uncompensated transfer that for five years, Medicaid can look at that. Medicaid can and will look at all of your financial information for the past five years.

However, if you were to put your assets into an asset protection trust, then after five years, 100% of those assets would be protected!

If you are single and need some skilled care, Medicaid will force you to spend all but \$1500 of everything you have before Medicaid will help pay for your care. Once that happens, Medicaid will take all of your income, except \$50 and then Medicaid will pay for the rest of your care.

Medicaid will pay only for a semi-private room. If you do some trust planning, you could get Medicaid qualified and use the funds from your trust to pay for a private room instead!
